

2. Safety

To avoid injury or damage, read and understand these instructions before installing or using the BOLD mini & BOLD maxi lamp.


Misuse of the device can result in serious property damage, as well as severe injuries or worse.

The instructions and other provided information must be kept for future reference and should also be passed on with the product if it is transferred to a new owner

The BOLD & BOLD XL lamp is intended exclusively for indoor use in private homes or similar environments (e.g., stores and offices).

Keep the device out of the reach of children to prevent it from being used as a toy.

Keep the device away from heat sources.





3. Installation

When installing the lamp for the first time keep all components and materials that contain product information (inside and on the packaging).

Place the lamp on a stable, flat surface

Be cautious when near the power cable.

Loose cables can pose tripping hazards.

Ensure that the power cable is not damaged.

Do not use a deformed or damaged power cable.

This lamp is not intended for through-wiring (looping-in) installations. Only connect the lamp as a single unit to the power supply.

No connection to other devices via the same power cable is allowed.



4. Usage

Do not use the device underwater. Doing so may result in severe injury or death.

Disconnect all connections before cleaning the device.

When cleaning the device, do not use excessive amounts of water.

Avoid letting water come into contact with the socket.

Use the device only indoors.

5 Maintenance Instructions

Before cleaning, unplug the device. Only use a dry cloth, or one that is lightly dampened with water. The cloth should be soft and lint-free. Do not use chemical cleaning agents, acids, or corrosive liquids to clean any parts of the device.

If the power cable is damaged or destroyed, it must be replaced by a qualified electrician.

If the light source of this device is defective, dispose of it according to national regulations as waste. Replace the bulb with a suitable E27 bulb of no more than 4 watts.

Disposal

Electrical devices and packaging must not be disposed of with household waste. Follow national regulations for waste sorting and disposal.

7. Troubleshooting

Issue: Lamp does not light up.

Solution:

Check the power supply.
Ensure the light bulb is correctly installed.
Verify if the light bulb is defective.

Issue: Power cable is damaged.

Solution:

Disconnect the device immediately from the power supply. Have the cable replaced by a qualified professional.



8 Intended Use


The device is intended for indoor use only. It may only be used with the components supplied with the BOLD & BOLD XL lamp or with components specifically defined for the lamp by Studio Matthias Lauche.

Modification of the product is not permitted, as it could make the device hazardous

9. Light Bulb

The following light bulbs can be used:



E27 G125 | G200

Only LED, maximum 4 watts.

Note: The light bulb is not included.
